

**Arizona Region Tournament Contract  
Junior Girls Club Division**

**Club 14's & 16's age divisions. Signed contract is due by December 16, 2009.**

I, *(official club representative)* \_\_\_\_\_ for the *(name of club)* \_\_\_\_\_ hereby agree to the following terms and conditions for my team(s) to participate in the 2008 "Club Division" tournaments of the Arizona Region Junior Division.

**The following terms are hereby understood and agreed upon:**

1. **The entry fee of \$ 810.00 is payable in two installments: \$ 405.00 by February 1, 2010 and the remaining \$ 405.00 by March 1, 2010.** Entry Fee includes 6 power tournaments plus the Region Championships Tournament. All late payments are subject to a \$100 late fee.
2. Failure to abide by the Arizona Region Code of Conduct (refer to membership application) will disqualify the violating team, violating team members, and violating team coach(s) for one calendar year. Falsification of age or identity will result in a 2-year suspension of membership opportunity with the AZ Region and USA Volleyball for the player, coach, club director and/or club.
3. Any forfeiture of a tournament results in my team(s) surrendering of the tournament fee to the Arizona Region. Forfeiture also equates to a last place finish in the forfeited tournament, and as such, my forfeited team(s) will be placed accordingly for the subsequent tournament.
4. It is further agreed that a commitment to playing the tournament schedule is strictly voluntary. Therefore, failure to show or notify the tournament director of non-participation at least 48 hours prior to the tournament will result in my team(s) being fined \$100 per non-participating team. If my team(s) fails to show or notify the Director of non-participation for two tournaments they will be banned from play in the Arizona Region Junior Girls Tournament Schedule for the remainder of the 2010 season.
5. Teams will stay within their respective age divisions as the season and team progresses. 14 & Under teams that do not qualify for the Championship Club Division will participate in the 14 Club Division. Teams participating in the Club Division will play in the AA or A Division at the Region Championships.
