

**Arizona Region Tournament Contract
2012 Junior Girls Championship Club Division**

Club 14's, 16's, 17's & 18's age divisions. Signed contract is due by Dec 14, 2011.

I, *(official club representative)* _____ for the *(name of club)* _____ hereby agree to the following terms and conditions for my team(s) to participate in the 2012 "Championship Club Division" tournaments of the Arizona Region Junior Division.

The following terms are hereby understood and agreed upon:

1. **The entry fee of \$ 830.00 is payable in two installments: \$ 415.00 by February 1, 2012 and the remaining \$ 415.00 by March 1, 2012.** Entry Fee includes 6 power tournaments plus the Region Championships Tournament. All late payments are subject to a \$100 late fee.
2. Failure to abide by the Arizona Region Code of Conduct (refer to membership application) will disqualify the violating team, violating team members, and violating team coach(s) for one calendar year. Falsification of age or identity will result in a 2-year suspension of membership opportunity with the AZ Region and USA Volleyball for the player, coach, club director and/or club.
3. These monies are non-refundable. Any forfeiture of a tournament results in my team(s) surrendering of the tournament fee to the Arizona Region. Forfeiture also equates to a last place finish in the forfeited tournament, and as such, my forfeited teams(s) will be placed accordingly for the subsequent tournament. No other team may participate in the tournament for the forfeiting team.
4. Part of participating in the Arizona Region tournaments is the referee assignment. Teams will have their players trained in scorekeeping and refereeing disciplines annually so as to be competent in their required duties. It is also required that teams fulfill their referee assignment for every match to keep our tournaments on schedule. Teams that leave without fulfilling their referee assignments will be fined \$100 and removed from further tournament schedules until the fine is paid.
5. It is further agreed that a commitment to playing the tournament schedule is strictly voluntary. Therefore, failure to show or notify the tournament director of non-participation at least 48 hours prior to the tournament will result in my team(s) being fined \$100 per non-participating team. If my team(s) fails to show or notify the Director of non-participation for two tournaments they will be banned from play in the Arizona Region Junior Girls Tournament Schedule for the remainder of the 2012 season.
6. Qualification - The 15's/16's and the 13's/14's teams that attempt qualification for the Championship Club Division will be selected for the Division based on their finish at the first Championship tournament. Forty-eight (48) teams will qualify in the 15's/16's and 36 teams will qualify for in the 13's/14's. The teams that do not qualify will be placed at the top of the Club Division in the respective age groups and participate in the Club #2 and subsequent tournaments. If 36 teams do not choose to enter into the 14's Championship Division, all will be accepted into the Division.
7. Teams in the Championship Club Division will blend with older or younger age teams as the season progresses. All teams will play in their respective age divisions at the Region Championships. The 13's & 14's teams will be competing with the same rules as those teams 15 and older. There will be no exceptions to the rules for 14 and under teams.
