

## 2018 Arizona Region Girls Jr. National Club Qualifier

This entry form and payment of \$500.00 made payable to Arizona Region is due in the Arizona Region office no later than 5 pm on Thurs, Mar 1, 2018 for all teams. **Late entries will not be accepted.**

**The Club Director of this team must initial each section to indicate they have read and understand the information in this box.**

\_\_\_\_\_ Teams entering the Arizona Region National Club Qualifier (NCQ) must be committed to attending the Girls Junior National Championships (GJNC). Teams that are not committed to attending the GJNC should not enter this tournament. If a team earns a bid at the AZ NCQ and then pulls out of the GJNC they will forfeit the GJNC entry fee (\$900) to USA Volleyball (if it is past the entry deadline) or the Arizona Region (if the deadline has not passed) and be subject to sanctions imposed by USA Volleyball and/or the Arizona Region. Teams may only play in the AZ NCQ with players that will be attending the GJNC tournament with this team. If players drop from this team leaving it unable to attend after qualifying, sanctions may be imposed on the player(s), the coaches, the team and/or the club. Teams that forfeit matches or disqualify themselves in the AZ NCQ to avoid finishing in a qualifying position are subject to sanction by the Arizona Region. The sanctions for all above may be financial and/or participatory and will carry over to the next season if needed.

\_\_\_\_\_ \$140 will be refunded to all teams participating in the AZ NCQ if they complete the tournament as far as their team qualifies to participate, do not withdraw from the tournament after the entry deadline and, do not forfeit matches to avoid qualification or elimination. The refund must be requested and will be made in June. If the club has a balance due with the AZ Region the \$140 will be applied to the balance due first. If no refund is requested the funds will roll over to the 2019 season.

\_\_\_\_\_ The team that places first in each age division will receive the bid to the National Division of the Girls JNC. The team that places second in each age division will receive the bid to the American Division of the GJNC. The teams that finish third through sixth are alternates and are required to remain committed to attend the GJNC until the reallocation bids have been filled and no Arizona teams may advance further. Any team that qualifies for the GJNC at a Jr National Qualifier at a higher level than qualified at the AZ NCQ is required to give up the bid that they received at the AZ Region tournament to allow another team to fill the Arizona Region bid.

\_\_\_\_\_ All Qualifying Teams: The 2018 Junior National Volleyball Championships Entry must be completed in AES and the Entry Form and Fee submitted to USA Volleyball within 10 days of qualification. All Alternate Teams must enter AES in the American Division and submit GJNC entry form to the AZ Region Office within 10 days of qualification. The fee will be paid upon acceptance. USAV will change the division level in AES if the team enters a different division than the bid they finally receive.
