



Arizona Region of USA Volleyball Out of Region Registration Agreement 2016-2017 Season

The USA Volleyball RVA Assembly Manual requires that a team register where the Team Representative resides. There is an exception that allows a team to register in an adjoining Region for the current season only if there is an agreement between the two Commissioners to allow it. The other Region is then empowered to govern that team for the duration of the registration.

USA Volleyball also requires that a person register in only 1 Region for the season. Memberships in more than one Region will not be allowed.

The Arizona Region has policies for club organization and participation that our clubs must abide by to participate in sanctioned events. To be granted the exception to register outside the Region where the Team Representative resides the Arizona Region policies must be adhered to as if the team resided in Arizona Region.

The following requirements are expected of all clubs registering in the Arizona Region. If the Out of Region teams cannot meet or choose not to meet these requirements then we ask those teams to register in the Region in which they reside.

Requirements

1. Club Requirements

- a. The Club Director and all adults associated with the club must be registered Arizona Region members with current background screens and SafeSport trained.
- b. Annual Club Registration Fee of \$200. This fee can be waived if the Club Director or appointed representative of the club attends the General Assembly and Junior Forum in September (for girls clubs) or Boys Junior Forum in August (for boys clubs). If you have both, you must attend both.
- c. The Club Director must sign and submit the Club Director Agreement.
- d. Open House and Tryout dates must be complied with. The Arizona Region is very strict when it comes to infringing on player eligibility with their school team. A club may not cause a player to become ineligible for their school team. Violations of this will result in disciplinary action.

2. Junior player requirements to be put on a roster

- a. Current member of the Arizona Region - register in Webpoint
- b. Submit a copy or have a birth certificate on file with the AZ Region
- c. Complete the SafeSport Form, sign and submit
- d. Complete the Concussion Acknowledgement Form and submit

3. Coach requirements to be put on a roster

- a. Current member of the Arizona Region - register in Webpoint
- b. Current background screen
- c. Current Coaches certification - must be a minimum of IMPACT certified and have taken some form of coach's education training if IMPACT certification is more than 3 years old. Coaches must maintain a current certification of education by attending approved coaches training a minimum of every 3 years.
- d. Have taken the SafeSport training online or through an IMPACT clinic.

4. Team Requirements

- a. Team Registration forms and fees submitted by the deadline date established.

- b. Tournament contracts, seeding forms, registration materials and fees are submitted and paid by deadline dates.
 - c. Each team that registers with the Arizona Region must sign a tournament contract and participate in the Arizona Region tournament schedule. A minimum of 80% attendance at tournaments is required for the out of Region teams to register with the Arizona Region the next season.
 - d. Players and coaches must become proficient in scorekeeping and R2 Referee and Line Judging by attending a clinic either in person or via the USA Volleyball Academy prior to the first tournament for that team.
5. High Performance Program & National Club Qualifier
- a. Teams are eligible to participate in the Arizona National Club Qualifier for the Arizona Region National and American bids to GJNC.
 - b. Players are eligible to participate with the AZ Region High Performance teams but they must attend tryouts and practices and follow all other requirements for the team just as if they lived in Arizona.

Memberships must be moved to the Arizona Region prior to adult or junior registration. Team Members and teams that are not going to play in the Arizona Region tournament schedule should not register in the Arizona Region.

If your team decides to participate with the Arizona Region understand it is for them to register and participate in our tournaments. Registering the team in the Arizona Region will allow them to participate in National Qualifiers and other interregional tournaments as an Arizona Region team.

The Arizona Region is not allowed to sanction a tournament, camp or clinic in another Region. If the club needs event sanctioning you will need to contact the Region in which your club is located for that. We can sanction and provide insurance certificates for the club tryouts and practices only.

This agreement is an annual agreement. If your teams are not participating in our tournaments or taking care of business as expected we will not renew this agreement for the following season. If you take care of business and find it works better for you then we can continue to register your players and teams with the Arizona Region with the agreement of the Commissioner of the Region where the club is located.

Agreement

I attest that I understand the above requirements for the club, teams, players, coaches, High Performance participation and Arizona Region National Club Qualifier. I understand the teams must participate in the Arizona Region tournaments in order to register in the Arizona Region. I understand the Arizona Region may not sanction an event at my location other than tryouts and practices. I understand that this Agreement is an annual agreement and must be agreed to, signed and approved each season. This form must be received by the Arizona Region Office no later than 8/30/2016 to prepare the club for registration before 9/1/16.

I agree to abide by the above requirements. For the 2016-17 season, I will register my
