RE: Junior Division Board of Directors Election Nominations

It is election time again. The elections will take place by written ballot via mail or email or at the Junior Girl's Region Championships beginning April 29th. Nomination forms will be accepted until Friday, April 14. The timing of the elections has changed from the Fall General Assembly to the spring to allow the new board members the opportunity to participate in the planning process for the upcoming season that takes place over the summer. The candidate information and ballots will be available by email, on the web site, at the sites of the Junior Region Championships and by mail after April 29th. Only Club Directors may vote for the Junior Board positions. This year two seats on the Junior Division Board of Directors will need to be chosen:

A Representative from the Metro Northwest, Metro Southwest will need to be elected. The Metro Northwest Rep (Shayne Lehman) and the Metro Southwest Rep (Jane LaBrot) are both leaving their positions for retirement from the club director ranks. Give them hearty thanks for their service when you see them or by email.

The term of office for the Junior Division Board of Directors is three years. Any current Club Director or Coach in the Arizona Region who is in good standing and has been involved with regional activities for a minimum of the last two years is eligible to run for a position within their zone on the Board. As a reminder, anyone elected to the Junior Board of Directors is expected to attend every Junior Board meeting, the planning retreat in July and to represent the Interests of juniors in their zone as well as the Region as a whole. Enclosed are a breakdown of the clubs by zone and a copy of the Job Description of a Junior Board member from the Arizona Region By-Laws. If you have any questions regarding the duties and responsibilities of the Board members, you may want to contact a current Board member.

This letter is your opportunity to nominate a Club Director from your zone for the Junior Division Board or to self-nominate if you are eligible. In either case, give some thought to the duties and responsibilities of the Board and the desires of the potential candidate. Please complete the following Nomination Form for each person you nominate and return it to the Arizona Region Office. Nominations must be received by 12 Noon on April 14th. If a Club Director cannot receive an email ballot they may request a ballot be sent by mail from the Arizona Region Office. The signed ballot will need to be received in the Arizona Region office (via fax or mail) by Saturday, May 13th to be counted.
