V. Establishment of start dates for Junior Girls

The AIA has published the HS State finals as 1A – 3A Nov 8, 4A Nov 17, 5A Nov 18. This does not give the Region a viable time frame for a tryout and commitment period and still allow the clubs to have their teams picked and committed by Thanksgiving.

There will be no changes made to the policy for tryouts and commitment dates. The Blackout period is Nov 1 through the last date of the high school state playoffs for the 15's and older.

Motion 2: To establish the tryouts dates for the girls 2009 season as follows: 14's and under may begin Nov 8th; 15's and older may begin Nov. 22nd. Malis/Saunders/MC.

Motion 3: To remove the tryout period and commitment date established at the last meeting. Saunders/Malis/MC

The Junior Board members are encouraged to research the Badger and Keystone Regions commitment dates and tryout policies for future policy recommendations.

Those board members that will be attending the YJOVD meetings should ask questions of other region representatives on what they are doing about tryouts and commitment dates.

Eric Hodgson will research and draw up a proposal requiring the clubs to provide a handout to all parents educating them to all their club policies and give them their player rights and parent rights when joining a club.

Coach Issue Feedback for Ethic & Compliance Officer

After interviewing several parents, both coaches and the club director for East Valley Juniors 16-1 team Dan Kaminskis has put forward recommendations on the incident involving the head coach. He asked for feedback on the proposed sanctions. The feedback is as follows:

1. Yes - not be a head coach or club director for two years
2. No - require the coach to attend behavior modification course. If takes a behavior modification class then he could be a head coach. The Jr Board is unclear as to how to require this.
3. N/A– the above must be completed prior to his next registration
4. Yes - Probation for 2 years – review after each year.
5. Yes – if have substantive complaints against him in the future then he will forfeit USAV and AZ Region membership.
6. Yes – must self disclose to any club that he applies to in the next two years.
7. Yes – note this in the EVJ file – note earlier intervention by the club director may have led to better experience for all involved.
8. Yes – a letter should be sent to the parents explaining the resolution of the complaints. Letter should not spell out exactly what is being done – general explanation. We must be careful regarding the legal implications as to slander.

Motion 6: recommend the Ex Board approve the revised recommendations regarding the EVJ coach. Saunders/Malis/MC

The Junior Board fees if Volleyball Festival is here there is no need to bring this tournament into our Region. It has not been worth the time and effort in the past.
